

# **Consultant - Job Description**

Job Summary: This Consultant (independent contractor¹) position will play a key role in expanding STAR across the West. Specifically, this position will assist in revising Field Forms and Scoring Sheets for the <a href="Colorado STAR Program">Colorado STAR Program</a> and developing new STAR Field Forms and Scoring Sheets for other Western states (WA, NM, WY, UT, MT, and ID). This will include providing leadership, logistical support, and coordination with local partners to facilitate multiple STAR Science and Steering Committees. Presuming success with this initial project, the Consultant may also contribute and pursue other projects around natural and working lands in Colorado and regional soil health. This could include projects around forestry, high-fungal compost, grant writing for federal grants, partnership with Colorado State University, and other topics.

This contract-to-hire position is expected to begin in May. The amount of work will vary week by week but may reach as much as ~20 hours per week by July.
